#### NOTICE OF FILING AND REQUEST FOR COMMENTS

D.P.U. 20-SQ-03 April 6, 2020

Investigation by the Department of Public Utilities into Blackstone Gas Company's 2019 Service Quality Report filed pursuant to Service Quality Standards for Electric Distribution Companies and Local Gas Distribution Companies, D.P.U. 12-120-D (2015).

On February 28, 2020, Blackstone Gas Company ("Company") filed with the Department of Public Utilities ("Department") the Company's 2019 service quality report ("2019 SQ Report") for the period January 1, 2019 through December 31, 2019. The Company's 2019 SQ Report compares its performance during 2019 with the Department's service quality guidelines set forth in Service Quality Standards for Electric Distribution Companies and Local Gas Distribution Companies, D.P.U. 12-120-D (2015) ("SQ Guidelines"), and the Company's service quality plan that the Department approved in Blackstone Gas Company, D.P.U. 16-82 (2017)). Per the SQ Guidelines, gas distribution companies may be subject to penalties for failure to meet the Department's SQ performance standards for: Class I/Class II odor calls, service appointments met, Customer Complains and Consumer Credit Cases. The Department has docketed this matter as D.P.U. 20-SQ-03.

The Department will accept written comments on the Company's 2019 SQ Report. Any person interested in commenting on this matter may submit written comments no later than the close of business (5:00 p.m.) on May 22, 2020. At this time, all filings will be submitted only in electronic format in recognition of the difficulty that parties and the Department may have filing and receiving original copies. On March 10, 2020, Governor Baker issued a state of emergency related to COVID-19 for the entire Commonwealth. Ordinarily, all parties would follow Sections B.1 and B.4 of the Department's Standard Ground Rules (D.P.U. 15-184-A, App. 1 (March 4, 2020)); however, until further notice, parties must retain the original paper version and the Department will later determine when the paper version must be filed with the Department Secretary. Importantly, all large files submitted must be broken down into electronic files that do not exceed 20 MB.

All documents must be submitted to the Department in pdf format by e-mail attachment to <a href="mailto:peter.ray@mass.gov">peter.ray@mass.gov</a> and <a href="mailto:Lauren.Morris@mass.gov">Lauren.Morris@mass.gov</a>. The text of the e-mail

must specify: (1) the docket number of the proceeding (D.P.U. 20-SQ-03); (2) the name of the person or company submitting the filing; and (3) a brief descriptive title of the document. All documents submitted in electronic format will be posted on the Department's website as soon as practicable at <a href="http://www.mass.gov/dpu">http://www.mass.gov/dpu</a>. To the extent a person or entity wishes to submit comments in accordance with this Notice, electronic submission, as detailed above, is sufficient. ### ORDER OF NOTICE

D.P.U. 20-SQ-03 April 6, 2020

Investigation by the Department of Public Utilities into Blackstone Gas Company's 2019 Service Quality Report filed pursuant to Service Quality Standards for Electric Distribution Companies and Local Gas Distribution Companies, D.P.U. 12-120-D (2015).

Blackstone Gas Company ("Company") is required to serve a copy of the attached Notice of Filing and Request for Comments no later than April 13, 2020 on the service lists in Blackstone Gas Company, D.P.U. 19-SQ-03; Blackstone Gas Company, D.P.U. 16-82 (2017)); Service Quality Standards for Electric Distribution Companies and Local Gas Distribution Companies, D.P.U. 12-120-D (2015); and on any person who has asked to be notified by the Company. The Company's service may be by electronic distribution, which the Department finds reasonable and consistent with the public interest. Finally, the Company shall prominently display the notice on its website from three business days following receipt of the notice from the Department through the end of the comment period. The Company must make return of service at the close of the comment period.
