### NOTICE OF FILING AND REQUEST FOR COMMENTS

D.P.U. 20-ERP-03 June 1, 2020

Petition of Blackstone Gas Company for approval of its 2020 annual gas Emergency Response Plan filed pursuant to G.L. c. 164, § 85B and 220 CMR 19.04(1).

On May 15, 2020, Blackstone Gas Company ("Company") filed its 2020 gas Emergency Response Plan ("ERP") with the Department of Public Utilities ("Department"). This filing was made pursuant to G.L. c. 164, § 85B and 220 CMR 19.04(1). The Department has docketed this matter as D.P.U. 20-ERP-03. The purpose of ERPs is to ensure that each gas company is adequately and sufficiently prepared to restore service to its customers in a safe and reasonably prompt manner during an emergency event. 220 CMR 19.00 et seq.

Any person interested in commenting on this matter may submit written comments no later than the close of business (5:00 p.m.) on **June 30, 2020**. At this time, all filings will be submitted only in electronic format in recognition of the difficulty that parties and the Department may have filing and receiving original copies. On March 10, 2020, Governor Baker issued a state of emergency related to COVID-19 for the entire Commonwealth. Ordinarily, all parties would follow Sections B.1 and B.4 of the Department's Standard Ground Rules (D.P.U. 15-184-A, App. 1 (March 4, 2020)); however, until further notice, parties must retain the original paper version and the Department will later determine when the paper version must be filed with the Department Secretary. Importantly, all large files submitted must be broken down into electronic files that <u>do not exceed 20 MB</u>.

All documents must be submitted to the Department in pdf format by e-mail attachment to <a href="mailto:peter.ray@mass.gov">peter.ray@mass.gov</a> and <a href="mailto:Lauren.Morris@mass.gov">Lauren.Morris@mass.gov</a>. The text of the e-mail must specify: (1) the docket number of the proceeding (D.P.U. 20-ERP-03); (2) the name of the person or company submitting the filing; and (3) a brief descriptive title of the document. All documents submitted in electronic format will be posted on the Department's website as soon as practicable at <a href="http://www.mass.gov/dpu">http://www.mass.gov/dpu</a>. To the extent a person or entity wishes to submit comments in accordance with this Notice, electronic submission, as detailed above, is sufficient. #### **ORDER OF NOTICE**

D.P.U. 20-ERP-03 June 1, 2020

Petition of Blackstone Gas Company for approval of its 2020 annual gas Emergency Response Plan filed pursuant to G.L. c. 164, § 85B and 220 CMR 19.04(1).

Blackstone Gas Company ("Company") shall serve a copy of the notice on: (1) the service list in <u>Blackstone Gas Company</u> d/b/a D.P.U. 19-ERP-03; (2) the Attorney General of the Commonwealth of Massachusetts; and (3) to any person who has asked to be notified by the Company no later than **June 5**, **2020**. The Company's service may be by electronic distribution, which the Department finds reasonable and consistent with the public interest. Finally, the Company shall prominently display the notice on its website from three business days following receipt of the notice from the Department through the end of the comment period. The Company shall make return of service at the end of the comment period.
