## NOTICE OF FILING AND REQUEST FOR COMMENTS

D.P.U. 21-97 September 10, 2021

Petition of Liberty Utilities (New England Natural Gas Company) Corp. d/b/a Liberty Utilities for approval of its annual pension adjustment factor reconciliation filing for effect November 1, 2021.

On August 6, 2021, Liberty Utilities (New England Natural Gas Company) Corp. d/b/a Liberty Utilities ("Company") filed a petition with the Department of Public Utilities ("Department") for approval of its annual pension and post-retirement benefits other than pensions ("PBOP") adjustment factors ("PAFs"). The Company made this filing pursuant to New England Gas Company, D.P.U. 07-46 (2007); Liberty Utilities (New England Gas Company) Corp, D.P.U. 15-75 (2015); and M.D.P.U. No. 1002P. The Department has docketed this petition as D.P.U. 21-97. In a separate filing, the Company is proposing other changes to its rates effective November 1, 2021, that also may have an impact on customers' bills. See Liberty Utilities (New England Natural Gas Company) Corp., D.P.U. 21-GAF-P6.

The Company proposes the following PAFs, effective November 1, 2021, and included for billing purposes in the Company's local distribution adjustment factor:

Rate Classes	PAF (per therm)
Residential (R-1, R-2, R-3, R-4, T-3, and T-5)	\$0.0668
Commercial/Industrial (Low Load) (G-41, G-42, G-43, T-41, T-42, and T-43)	\$0.0389
Commercial/Industrial (High Load) (G-51, G-52, G-53, T-51, T-52, and T-53)	\$0.0223

Any person who desires to comment on this matter may submit written comments no later than the close of business (5:00 p.m.) on **Friday, October 1, 2021**. At this time, all filings should be submitted only in electronic format consistent with the Commission's June 15, 2021 directive related to modified filing requirements. Ordinarily, all parties would follow Sections B.1 and B.4 of the Department's Standard Ground Rules (D.P.U. 15-184-A, App. 1 (March 4, 2020)); however, until further notice, parties must retain the original paper version and

the Department will later determine when the paper version must be filed with the Department Secretary.

All written comments or other documents should be submitted to the Department in **PDF format** by e-mail attachment to <a href="mailto:dpu.efiling@mass.gov">dpu.efiling@mass.gov</a> and <a href="mailto:henry.d.kahn@mass.gov">henry.d.kahn@mass.gov</a>. In addition, all written comments should be emailed to the Company's attorney, Ronald J. Ritchie, Esq., at <a href="mailto:r.j.ritchie@libertyutilities.com">r.j.ritchie@libertyutilities.com</a>. The text of the e-mail must specify: (1) the docket number of the proceeding (D.P.U. 21-97); (2) the name of the person or company submitting the filing; and (3) a brief descriptive title of the document. The e-mail must also include the name, title, and telephone number of a person to contact in the event of questions about the filing. The electronic file name should identify the document but should not exceed 50 characters in length. Importantly, all large files submitted must be broken down into electronic files that <a href="mailto:do not\_exceed 20 MB">do not\_exceed 20 MB</a>. All documents submitted in electronic format will be posted on the Department's website through our online File Room as soon as practicable (enter "21-97") at: <a href="https://eeaonline.eea.state.ma.us/DPU/Fileroom/dockets/bynumber">https://eeaonline.eea.state.ma.us/DPU/Fileroom/dockets/bynumber</a>.
